The Pacific is in a period of flux with new governments and uncertain economic times. A stellar cast of leading Pacific thinkers and policy makers will debate and discuss the latest economic and political developments in the region. Come and listen to two ministers of finance, two central bank governors, two heads of major civil society organisations, a leading economic adviser, and a top economist from the region.

What challenges face the new governments of Timor and PNG? How robust is the Solomon Islands' recent high growth? How can Fiji escape economic stagnation? Is Vanuatu on

the way back to the high growth it experienced prior to the global financial crisis? What can Tonga do in the face of declining remittances and tourism? How much of a risk is Samoa's large fiscal deficit? The panelists will also address regional issues, such as prospects for the PACER Plus trade agreement, and the role of aid and migration.

The 2012 Pacific Update will consist of three panel discussions; on PNG and Timor-Leste; Vanuatu, Tonga and Samoa; and on Solomon Islands and Fiji. There will be ample time for Q & A.
