Forum background

Freshwater in Oceania is variably distributed and not always accessible in the places and volumes required for human and ecological needs and desires. This includes for drinking and sanitation, agriculture, industry and a range of other land-based economic, social and cultural purposes. There are also issues in many areas of Oceania due to conflicting values and understandings about how water and connected land should be used and managed, and whose rights it should be to do so. Prime examples are the Bonriki groundwater reserved in Kiribati, used to support dense urban populations in Tarawa and the sparsely populated Kimberley region of Western Australia. This latter area, with seemingly bountiful water resources are seen by many, including in the current Australian Government, as in need of 'development', despite competing claims on the need for stewardship and avoiding the mistakes of the 'South' from many including traditional custodians of the region.

This Water Governance in Oceania forum seeks to unravel and provide a space for discussion of these issues.

The forum will commence on day one with a facilitated conversation and Q&A between researchers and practitioners from across Oceania draw on the results of the Fonds Pacifique water governance project**. The speakers will unpick some current challenges, future directions and how certain types of participatory research and innovation can be used to enhance water governance and sustainable development in the region.

On day two, there will be a conference that allows researchers and practitioners from Oceania to present a range of results and insights from recent work, including from the Fonds Pacifique water governance project. The speakers from Tonga, Kiribati, New Caledonia, France and Australia will unpick some current challenges, future directions and how certain types of innovations, such as participatory planning and games, as well as technical monitoring and evaluation approaches, can be used to enhance water governance and sustainable development in the region.

The forum is a public event and will be recorded to allow greater access to the discussion from researchers and practitioners across Oceania and further afield.
